## **RULES, REGULATIONS AND CONSIDERATIONS**

- 1. Ordinary Members and Training Members shall be subject to the Rules and Regulations of the Club from the date of their application. A copy of these Rules and Regulations and the Constitution shall be made available to each Ordinary Member and Training member of the Club should they request same.
- 2. Honorary Life, Ordinary, Training and Family members and Club Trainers may not be members of another club with similar objects, except with the permission of the Committee.
- 3. Membership shall be Honorary Life, Ordinary, Training and Family.
- 4. The annual subscription or as the Club may from time to time decide is laid out in the Fees Section of the application form.
- 5. Annual subscriptions are paid once off annually at the time that you join and subsequently at the anniversary of your membership each year.
- 6. Training fees shall be due and payable on the first Saturday of each month Training Members payable 3 months in advance as per the tariffs under the Fees Section of the application form. A member shall not be liable for training fees for any month or months in the event of such member (or such member's dog) being unable to attend training classes as a result of illness or temporary disability for the full period if notice was given in writing to the Club in advance. Bitches on heat are still liable to pay for the weeks that they do not attend
- 7. Complaints or suggestions shall be made in writing to the Secretary, who shall bring all such information to the attention of the Committee at its next meeting.
- 8. The Committee shall have the powers to make, amend or repeal the Rules and Regulations of the Club.
- 9. Any member winning trophies belonging to the Club, shall be entitled to possession only upon signing the Club Trophy Register. Such person shall be obliged to return the trophy concerned to the Trophy Steward, not less than 30 days prior to the next presentation to be held by the Club, and in the same condition in which it was received. The Club reserves to itself, at all times, the right to take such steps as it may deem necessary in the event of a trophy being returned in a damaged condition.
- 10. Only members approved by the Committee are allowed to have club keys and unlock the Club grounds and the Clubhouse.
- 11. ALL dogs attending classes shall be kept on a suitable lead and under strict control at all times except when working under the orders of the Instructor. Members must at all times strive to limit barking, biting and dogs fighting.
- 12. Any harsh treatment of a dog is strictly prohibited. Persons acting violently towards their dogs or any other person on the premises will be asked to leave immediately.
- 13. As a common courtesy, members and guests should limit their driving speed to MAX 15Km/h.
- 14. ALL members should please ensure that they clean up after their dogs and themselves there is a poop scoop in the Clubhouse.
- 15. All members must present to either the Secretary or Treasurer their dog's Vaccination Record at least once a year when subscription fees are due.
- 16. No female dogs in season (heat) are allowed at the Club.
- 17. Owners are solely responsible for preventing injuries and for offering assistance to those injured by their dog(s).
- 18. If your dog inflicts any injury, give your name and telephone number to the other owner before leaving the Club.
- 19. Please repair any damage your dog(s) create while training/attending at the Club.
- 20. Children under 12 must be accompanied by an adult. No children or spectators are allowed on the training field during training.
